- New equipment rebate(s) must be submitted no later than 3 months after purchase date and must be installed on cooperative's lines.
- Rebates are in place through December 31, 2024. Funds are limited, so members are encouraged to submit as soon as possible.
- Rebates submitted after December 31, 2024, will not qualify if the rebate is no longer offered in 2025.
- Rebates not allowed for a measure and a component of that measure. For example, if an air source heat pump has a variable speed blower motor, the air source heat pump qualifies for a rebate but not the variable speed blower motor.
- Rebate not to exceed the cost of equipment. Additional eligibility criteria may apply. Contact cooperative for details.
- All documentation listed below must be <u>submitted no later than 3 months after the purchase date</u>.
 - ✓ This Rebate Form. Requests missing required information will be returned.
 - ✓ A dated copy of your receipt or invoice for each item purchased. Note: Proposals are not accepted.
 - ✓ AHRI Certificate, for all Air Conditioners, Heat Pumps and ECM Blower Motors.
